SPECIFICATIONS & WARRANTY

WHAT IS ASTM F964?

Scope

ASTM F964-13 is considered the “end all, beat all” testing specification for vinyl fence. The purpose of this specification is to establish a recognized standard of quality for exterior vinyl profiles for use in assembling agricultural, commercial, and residential fencing and railing. This specification covers Shoreline Vinyl Fence sections and the EverStrong Profiles® used to fabricate them.

Materials

Shoreline Vinyl Fence Products are manufactured using Rigid Poly Vinyl Chloride (PVC) compounds for exterior-profile extrusions that meet the requirements of ASTM Specification D4216.

Manufacture

Shoreline Vinyl Fence Products are manufactured to meet cell Class 3–30233–23 as defined in Specification D4216. Shoreline compounds have higher cell classification because one or more properties are superior to those used in standard acceptable compounds.

Color/Consistency Testing – The PVC compound in extruded section shall maintain uniform color and be free of any visual surface or structural changes, such as peeling, chipping, cracking, flaking, or pitting after weathering at intervals of six months and one year for white and for six months, one year, and two years for all other colors in hot, dry climate such as Phoenix, AZ; a hot humid climate, such as Miami, FL; and a temperate northern climate, when tested in accordance with ASTM Performance Weathering Requirements (TABLE 1).

Weathering Testing – The PVC compound shall have a minimum impact resistance of 0.6 in.-lb/mil (2670 J/m) after weathering six months and one year in a hot, dry climate such as Phoenix, AZ; a hot, humid climate, such as Miami, FL; and a temperate northern climate, when tested in accordance with ASTM Performance Weathering Requirements. The PVC compound shall have successfully met the weathering requirements prescribed for six months at each climatic testing site prior to use in production of exterior-profile extrusions, when tested in accordance with ASTM Performance Weathering Requirements (TABLE 1).

Quality Assurance

Shoreline Vinyl Fence Products are run through dimensional tests at the startup of a production run and every two hours thereafter including flattening, extrusion quality, impact resistance, warp, color comparison with standard color samples, capstock thickness, and bond testing will be done at the startup of a production and once per shift thereafter with a minimum of two tests per 24 hours of production.

WARRANTY

Shoreline Vinyl Systems (“Shoreline”) warrants to the purchasing homeowner (the “Purchaser”) that his or her Shoreline Vinyl Systems Fence as applicable, will be free from manufacturing defects including peeling, flaking, blistering and corroding when subject to normal and proper use, subject to the following terms and conditions.

Should any manufacturing defect occur in a Shoreline Vinyl Systems Fence during the lifetime of the Purchaser (and provided that the Purchaser is still the homeowner at the time such defect is reported), Shoreline will, at the sole option of Shoreline, repair or replace the defective Shoreline Vinyl Fence or the defective parts of such Shoreline Vinyl Fence.

Limitations

In the event of any repair or replacement of fence product under this limited warranty, Shoreline shall not be liable for labor charges or other expenses incurred in connection with removal or installation of either the original or replacement product. Shoreline reserves the right to refund the amount paid by the Purchaser for the fence product instead of repairing or replacing the defective fence product. In the event of repair or replacement under the terms of this limited warranty, the original limited warranty shall apply to the repaired or replaced fence product and will extend for the balance of the original limited warranty period only. The coverage offered by this limited warranty automatically ends upon the earlier of the sale of the property or death of the last of the Purchasers.

In the event a fence product is purchased by or installed upon property owned by a corporation, governmental agency, partnership, trust, religious organization, school, condominium, homeowner association, cooperative housing arrangement, apartment building or any other type of building or any other premises not consisting of a single family home used by an individual homeowner as his or her primary residence, the limited warranty period will be twenty (20) years from the installation date of a Shoreline Vinyl Fence, subject to proration as set forth above.

Shoreline does not warrant installation or defects caused by installation. This limited warranty is void if any of the following occurs: (a) improper application techniques; (b) misuse, neglect or improper storage; (c) altering or changing the product by use of applied heat, welding, solvents, epoxies or any other alterations beyond the manufacturer’s control; (d) impact of objects, fire, flood, hurricane, tornado, wind storms, casualty, or “Acts of God”; (e) painting the surface of the product; (f) adverse effects of air pollution, mold and Normal Weathering of surfaces. The manufacturer of this product does not recommend or approve this product for all possible end use applications. The appropriate local code authority should be consulted as to its safety and applicability for intended usage.

Shoreline reserves the right to discontinue or modify any of its products, including a color or woodgrain, without notice to Purchaser. Shoreline shall not be liable in the event the replacement product varies in color or gloss level in comparison to the original product as a result of Normal Weathering or if a fence product has been discontinued or changed. If Shoreline replaces or repairs any product under this limited warranty, it may substitute products determined by Shoreline to be of comparable quality or price range.

To submit a warranty claim, the “purchaser” must notify the original company of purchase who will supply to Shoreline the documentation necessary.

THE STATEMENTS CONTAINED IN THIS LIMITED WARRANTY SET FORTH THE ONLY WARRANTIES EXTENDED BY SHORELINE, AND ARE IN LIEU OF ALL OTHER WARRANTIES, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND WARRANTIES OF FITNESS, AND THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF SHORELINE AND THE PURCHASER’S EXCLUSIVE REMEDY FOR BREACH OF SHORELINES’ WARRANTY. TO THE EXTENT PERMITTED BY APPLICABLE LAW, SHORELINE SHALL NOT BE LIABLE TO THE PURCHASER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THE FENCE PRODUCT.
